

# HIPAA Privacy Authorization Form

## Authorization for Use or Disclosure of Protected Health Information

The Health Insurance Portability and Accountability Act (HIPAA) establishes patient rights and protections associated with the use of protected health information. HIPAA provides patient protections related to the electronic transmission of data (“the transaction rules”), the keeping and use of patient records (“privacy rules”), and storage and access to health care records (“the security rules”). HIPAA applies to all health care providers, including mental health care providers. Providers and health care agencies are required to provide patients a notification of their privacy rights as it relates to their health care records. Even though Biblical Counselors are not bound by standards that pertain to the law, based upon the law and the Biblical counselors ethic to “do harm to no one” **Nyoo Mind Biblical Counseling, LLC** and its counselors will follow the law as it pertains to confidentiality and privacy.

This Patient Notification of Privacy Rights informs you of your rights. Please carefully read this Patient Notification. It is important that you know and understand the patient protections HIPAA affords you as a patient.

Confidentiality and privacy are central to the success of the counseling relationship; therefore, **Nyoo Mind Biblical Counseling, LLC** will do all we can do to protect the privacy of your counseling records. If you have questions regarding matters discussed in this Patient Notification, please do not hesitate to ask.

### I. Preamble

Records are kept documenting your care as required by law, professional standards, and other review procedures. HIPAA clearly defines what kind of information is to be included in your “designated medical record” or “case record” as well as some material, known as “Progress Notes” which is not accessible to insurance companies and other third-party reviewers. HIPAA provides privacy protections about your personal health information, which is called “protected health information (PHI)” which could personally identify you. PHI consists of two (3) components: counseling, and payment.

Counseling refers to activities/sessions I provide, coordinate or manage your care or other services related to your care. Examples include a counseling session or if the counselee permits communication with your primary care physician about the care you receive.

Counseling operations are activities related to my performance such as quality assurance. The use of your protected health information refers to activities **Nyoo Mind Biblical Counseling, LLC** will conduct for scheduling appointments, keeping records, and other tasks related to your care. Disclosures refer to activities you authorize such as the sending of your protected health information to other parties (i.e., your insurance company).

## **II. Uses and Disclosures of Protected Health Information Requiring Authorization**

If you request **Nyoo Mind Biblical Counseling, LLC** will send any of your protected health information of any sort to anyone outside my office, you must first sign a specific authorization to release information to this outside party. A copy of that authorization form is available upon request. "Counseling notes" are the therapist's notes "recorded in any medium by a mental health provider documenting and analyzing the contents of a conversation during a private, group, or joint family counseling session and that are separated from the rest of the individual's medical record." "Progress notes" are private and contain information about you and your treatment.

## **III. Uses and Disclosures Not Requiring Consent or Authorization**

By law, protected health information may be released without your consent or authorization under the following conditions:

- Suspected or known child abuse or neglect
- Suspected or known sexual abuse of a child
- Adult and Domestic abuse
- Judicial or administrative proceedings (i.e. you are ordered here by the court)
- Serious threat to health or safety (i.e. "Duty to Warn" and Threat to National Security)

## **V. Couselee's Rights and Our Responsibilities**

You have a right to the following:

- The right to request restrictions on certain uses and disclosures of your protected health information which I may or may not agree to but if I do, such restrictions shall apply unless our agreement is changed in writing
- The right to receive confidential communications by alternative means and at alternative locations. For example, you may not want forms mailed to your home address so I will send them to another location of your choosing.
- The right to inspect and copy your protected health information in the designated record and any billing records for as long as protected health information is maintained in the record.
- The right to insert an amendment in your protected health information, although the Biblical counselor may deny an improper request and/or respond to any amendment(s) you make to your record of care.
- The right to an accounting of non-authorized disclosures of your protected health information.

- The right to a paper copy of notices/information from **Nyoo Mind Biblical Counseling, LLC** will, even if you have previously requested electronic transmission of notices/information.
- The right to revoke your authorization of your protected health information except to the extent that action has already been taken.

For more information on how to exercise each of these aforementioned rights, please do not hesitate to ask for further assistance on these matters.

**Nyoo Mind Biblical Counseling, LLC** will recognize the law to maintain the privacy of your protected health information and to provide you with a notice of your Privacy Rights and our duties regarding your PHI. Nyoo Mind Counseling Services reserves the right to change its privacy policies and practices as needed with these current designated practices being applicable unless you receive a revision of these policies when you come for future appointment(s). Our duties in these matters include maintaining the privacy of your protected health information, to provide you with a notice of your rights and our privacy practices with respect to your PHI, and to abide by the terms of the notice unless it is changed and you are so notified.
