- If N(y)oo Mind Biblical Counselors have reason to believe that you are involved in or have knowledge of abuse or neglect of a child; or abuse, neglect, or exploitation of a person who is elderly or has a disability, or
- If N(y)oo Mind Biblical Counselors are ordered to disclose by state or federal courts, by court order.

Additionally, N(y)oo Mind Biblical Counseling, LLC may disclose the information if you sign a release form granting permission to designated third parties to receive information that you request me to share. N(y)oo Mind Biblical Counseling, will never disclose your information for any reason without your knowledge of intent.
